We the undersigning NGOs and humanitarian organizations, on the basis of the following statements and documentation reported by the Kurdish Red Crescent and other Humanitarian actors, deplore the aggression moved by Turkey against Efrîn region in north Syria, from where we get reports showing that the violations of human rights have reached to tragic levels.

There are evidents that the Turkish state is braking international law and opposing the international conventions and resolutions during the ongoing massacres against the indigenous peoples of the region and also against the persons displaced in the same area.

The Turkish state and some Free Syrian Army groups started this military attack on the 20th of January 2018 with an intensive shelling by Turkish warplanes, targeting both military sites and civil buildings in Efrîn such as houses, schools and hospitals.

The Kurdish Red Crescent documented the death of 227 civilians, among those 32 child and 28 women, and 651 civilian are injured, among those 87 children and 93 women, due to Turkish attacks until 26'th of February.

Moreover, others major attacks by tanks and other heavy weapons from the Turkey's soil at the border with Syria, are targeting the Northern, Eastern and Western areas of Efrîn region, causing massive displacement within the region and many civillian casualties. According to UN, in the first 2 weeks of Turkish attack, more than 16.000 have been displaced due to the bombardments, and the number was increased until the end of February. All Efrîn area is facing a very serious humanitarian crisis because of these attacks, with the direct consequence of a lot of innocent people being massacred or were being badly injured and many others were displaced or lost their houses.

There are grave concerns for the civilians who are in the remote areas and who lack access to healthcare, shelter and food. We also observed a rising number of psychilogical disorders- like post-traumatic stress disorder, especially among children – that are deeply affected by the ongoing attack.

The Kurdish Red Crescent and other humanitarian actors reported that there are still died bodies (civilians and military) those have not been evacuated, because the targeting from the Turkish side and FSA, and the last targeting on the humanitarian actor was on the IRCC and SARC convoy on 1st of March.

Although the United Nations Security Council voted unanimously on Saturday 24th of February in favor of a 30-day cease-fire in Syria under 2401, this has not been applied neither in Gouta nor in Efrîn.

Between 24th of February and 1st of March, according to the Kurdish Red Crescent there were 118 casiulties in Efrîn 36 died and 82 injured, including Civilians and military cases.

Since we are working closely in North Syria and we see how the humanitarian crisis is developing, we call for immediate cessation of the Turkish aggression with the Free Syrian Groups battalions accompanying them on the area of Efrîn.

EFRÎN

Efrîn is a district, as well as a city, that is 40 Kilometers to the North West and has become part of self-autonomous rule since its establishment in 2012. Later it became part of the Democratic Federation of Northern Syria, declared in 2016.

The region's population was nearly 500,000 before 2011. It is composed of many towns and about 380 vilages. After 2011 and due to massive military operations between the regime and the opposition in Idlib and Northern Aleppo suburbs - in addition to the fall of opposition-controlled areas in Aleppo city to the regime in December 2016 - the area was considered safe for Internally Displaced Persons (IDPs) from many areas all over Syria. The number of IDPs is roughly 250,000, in addition to many families from the region who used to live in Aleppo before 2011. The current unconfirmed number of the civilians in Efrîn region is around 800,000 people including IDPs.

Despite many battles between the SDF that control the area, and some Islamist (including AQ's Nusra front) and other armed groups, the SDF always maintained its control over the region since it took over in 2012.

The Causes of Emigration to Efrîn Province

Efrîn is located in the northwestern corner of Syria, and it is 60 Km away from the Aleppo province. Emigration to the province began since the beginning of the crisis in 2011, because of the clashes between the Syrian regime and the free army. With the intensification of the conflict, the flow of refugees to the province increased to more than 300,000 IDPs, coming from various Syrian regions near Efrîn (such as Aleppo, Hamma, Al-Raqqa, Idlib, Kobani, Izaz, Al-Tabqqa, Ihzer, Tel Hasel, Tel Aaran, Kefr Naya) and other regions.

IDPs distributed to the villages, cities of Efrîn and the shelters as follows:

in the province center: 143505 IDPs.

- in Sherawa area: 76005 IDPs.

in Jendres area: 43510 IDPs.

- in Rajo area: 6970 IDPs.

in Shran area: 10105 IDPs.

- in Shekh Al-Hadid area: 780 IDPs.

- in Bilbil area: 1645 IDPs.
- in Maabtli area: 2207 IDPs.

The total number of the confirmed registered are 284,727 IDPs.

DETAILED FILE ON THE COMMITTED MASSACRES DONE BY THE TURKISH AIRSTRIKES WITH ITS ALLIED FORCES ON EFRÎN

The first massacre in the first day of the Turkish airstrikes 20\1\2018:

The Turkish military airstrikes targeted Efrîn city at around four o'clock afternoon in Turneda village several times. The attacks caused damages in people's houses and souls, which led to a terrible massacre and several families were displaced to Efrîn from Idlib.

Unfortunately most of the families have lost some members of their families during these attacks.

During these attacks, Hemada family were surprised by the sounds of the Turkish airplanes. The kids went out to see what was going on, but when the mother rushed to get her children in, she saw them on the ground with their organs out of their bodies.

The nine-year old Yehya Hemeda died; even though the doctors tried hard to rescue him. His brother Khaled Hemeda who was eleven years old suffered from very bad injuries in abdomen and his situation is critical. Not to mention the injured member in the family.



The second massacre in the second day of the Turkish airstrikes 21\1\2018:

In the second day of the Turkish airstrikes on Efrîn, Al-Hussien family in Jilboul town in Sherwa district, was the target of Turkish shells. This miserable family who consists of three families together came from Idlib to Maaret Nouman town, as IDPs migrating because of the conflict in their area to Efrîn region, looking for a safer life and shelter for their children.

The family managed to get a house in Jilboul village and ran a ranch for chickens, but the family faced a very awful massacre leaving 24 person injured among them 11 died and 8 wounded and 5 missing members, most of them were children and women.

The victims are:

- 6.Ibrahim Mohemmed Ibrahim thirty five years old.
- 7.Khaled Mohemmed Ali thirty six years old.







The third massacre by the Turkish airstrikes 23\1\2018:

Turkey forces along with the free army and other gangs bombed randomly the civilians in Jendayrs district, with heavy weapons. The Turkish airstrikes focused on Al-Hemam village. Turkish and FSA shells left a lot of damages among civilians causing a terrible massacre between kids, women and elderly people. The numbers of victims reached to 45 people from them five died and 41 wounded. The medical center was also attacked and the Kurdish Red Crescent's ambulance got shot by many shots.

The Died people are:

- 1.unknown child.
- 2. Elmaza Shieko Horo fifty years old.
- 3.unknown women fifty five years old.
- 4.unknown person nineteen years old.
- 5. Gigar Khon fifteen years old.









The fourth massacre by the Turkish airstrikes 26\1\2018:

The bombs, shells and rockets target almost all towns, villages and regions in Efrîn. This time the Turkish forces with FSA targeted Moubeta district leading to a very terrible massacre in a civilian family who were displaced from Tel-Kirah town in North Aleppo. The victims were seven members from the same family. Al-Khater family came to Efrîn looking for safe shelter for their children. But unfortunately they became an easy target for Turkish shells which destroyed their homes while they were sleeping.

The six victims were:

- 1. Yousra Taha Al-Khater nine years old.
- 2. Soulieman Taha Al-Khater fourteen years old.
- 3. Zaky Taha Al-Khater fifteen years old.
- 4. Moustefa Taha Al-Khater seventeen years old.
- 5.Amena Taha Al-Khater fourty years old.

6. Taha Moustefa Al-Khater fourty five years old.

As for the seventh member Safaa Taha Al-Khater nineteen years old, she had some minor injuries, the doctors assure that her psychological situation is very bad after she knew that all her family were dead.









The fifth massacre by the Turkish airstrikes 28\1\2018:

Efrîn people woke up to a very awful massacre on Gubela village in Sherwa district. Keno family who consists of three families together came to Efrîn region looking for a better life. The family worked in grazing herds of sheep. According to the father (the only survivor), the Turkish airstrikes bombed their houses with four rockets continuously making the house fall to the ground. When the rescue team of the Kurdish red crescent arrived to the place, they found a yard full of parts of bodies to the extent the team couldn't recognize the shredders of humans and herds.

The victims of this massacre were mostly children and women.

The eight victims are:

1.the child Kemal keno seven months.

- 2.the child Safaa Keno seven years old.
- 3. Hesen Keno thirteen years old.
- 4. Hanedy Keno fifteen years old.
- 5. Amera Keno seventeen years old.
- 6. Jourya Keno fourty five years old.
- 7. Fatema Abd Rebo fourty years old.
- 8. Rewan Al-Aswad twenty years old.

While the rest they were badly wounded.

The names of wounded:

The sixth massacre by the Turkish airstrikes 31\1\2018:

The Turkish airstrikes once again targeted Efrîn city-Turneda village randomly. The attacks caused a very painful massacre to family who already ran away from the Turkish fires in Jalema town. Aleko family were taking place in one of the basements in Turenda village as a temporary place. The reckless shell went directly to the basement leading to many injuries with their little child as a died.

The wounded are:

- 1. Mohemmed Aleko seventy five years old.
- 2.Ali Ekrem Aleko fourty years old.
- 3. Mohemmed Ahmed Aleko ten years old.
- 4. Abedo Mousa Mousa eleven years old.
- 5.Gulah Mohemmed Khalil fourty years old.











SUSPECTED USE OF CHEMICAL WEAPONS IN EFRÎN

On February 16, 2018, Avrin Hospital received at 6:00 pm (6) cases suffering from the following signs and symptoms (Sever respiratory problems, cough, skin rash) one of the contaminated patient (Abdel Rahman Chalik) in addition to those symptoms and signs, was suffering of (narrowing the cornea).

One of the paramedics was also was suffering as a result of contact from skin itching symptoms and tearing in the eyes. The appearance of the same signs and symptoms on all people exposed to the this substance is undoubtedly a chemical contamination (Aranda village in the area of Shie District.

The victims are:

- 1. Wadah Khalil, 35 years old
- 2. Adnan Chalik, 36 years old
- 3. Abdulrahman Chalik, 29 years old
- 4. Ahmed Hamo 38 years old
- 5. Mahmoud Rashid Hassoun 33 years old
- 6. Mohammed Hakki is 43 years old

This was not the first time for KRC teams to be witnesses of the use of chemicals in Efrîn on 2-2 2018 At 3:00 pm. KRC Trauma Stabilization Point in Rajo received five cases in the name of (Abdullah Ibrahim 32 years old - Ahmad Husni Abdu, 37 years old - Melaz Afo 22 years old - Mamo Jammu, 30 years old) suffering from the following Signs and Symptoms (Vomiting - difficulty breathing - fainting.) These five people were sheltering in a cave when they were targeted.

The Kurdish Red Crescent team that tested these contaminated people was trained extensively during the Battle of Raqqa to identify and respond to the chemical contamination and casualties according to the basic standards of the World Health Organization under project funded by European Union / ECHO.

DETAILED FILE ON CHILDREN VICTIMS OF TURKISH ATTACKS ON EFRÎN

From 20\1\2018 to 21\2\2018

UNICEF laws assure that children have the right of living, learning, playing, laughing and expressing themselves. However, in Efrîn children lost their innocence, their right of learning, playing and laughing because of the Turkish attacks on their houses, schools and parks. Efrîn's children aged too much because of their deep injuries as they lost their lives and the details in them. One child lost his hand, another lost his foot and most of children lost their family members with no one left. Children of Efrîn sense fear, instability and anger. They also live in basements that are not suitable for living.









Turkish government claims that it fights terrorism but children are targeted as the number of victimized children have reached until 26-2-2018 as we documented to (82) among them 57 wounded and 25 died.

Kilaho family that lives in Basutah village in Sherwa district had a very horrible massacre by turkish shells in 19\2\2018. One of Kilaho's relatives reported that the

kids were playing outside with laughter and smiles on their faces when suddenly they started crying, screaming and the blood spread all over the place on their tiny bodies. Kilaho's kids will never laugh again because of their deep injuries.

1. Heva Ahmed Kilaho 13 years old.



Jendyras district:

Jendyras is the district attacked most and shelled to the extent victims are occurin everyday. In Jendyras children live in basements and see death every day forgetting the meaning of the normal life and why they are children. Jendyras' children dream of quite sleeping away from bombs and rockets' sounds. In 23\1\2018 Turkish airstrikes caused a massacre between civilians among them 17 children.

- 1. Aya Nebo 7 years old got injury in her belly.
- 2. Ameen Rizan 10 years old got injury in his head.
- 3. Suzan Sibhy Sulieman 11 years old got injury in her head and forearm.
- 4. Jhonny Rizan 11 years old got injury in his head.
- 5. Mustefah Mohemmed Khelof 12 years got fragment in his lower limbs.

- 6. Aya Kedro 15 years old got fragments in her right knee.
- 7. Mustefah Khelof 14 years old got injury in his both left and right legs.

1. Nazy Yousef Yousef 16 years old in 25\1\2018.

The wounded are:

- 1. Yousef Abd Alruhman 15 years old got injury in his head in 21\1\2018 in Jelma village.
- 2. Mohemmed Jamil Sulieman 4 years old got a fragment in his leg in 22 \1\2018 in Til Silour village.

3.Asya Mohemmed Khelof 15 years old got a fragment in her lower parts in 26\1\2018.

4.Hameed Rashid Mehmoud 4 years old got shot in his forehead in 4\2\2018 in Kefer Safra.

5.Ali Hesen Al Masry 13 years old got many fragments in his body in 16\2\2018 in Yelan Khouz village.



6.Akram Osman Shiekho 17 years old got arterial bleeding in 19\2\2018 in Jelemah village.

As for the twins from Dier Belawt village:

7.Mehmoud Beder Dirmoush 10 years old got fragments in head and belly.

8. Mustaffah Beder Dirmoush 10 years old got injury in his ureter.

The twins' mother Diebah Ahmed 35 years old got sniper's shot in her thigh.

Mobeteh district:

Most victimized children in Mobeteh district were victims of a horrible massacre in 26\1\2018. Al Kheter family was IDPs from Til Kirah came to Mbeteh looking for security and better life but unfortunately they were targets of Turkish rockets and shells. The only survivor daughter said that it was early in the morning they were sleeping when Turkish military planes surprised them. Safaa Al Kheter's family were seven members, the victimized children are:

The victims are:

- 1. Yousra Taha Al-Khater nine years old.
- 2. Soulieman Taha Al-Khater fourteen years old.

- 3. Zaky Taha Al-Khater fifteen years old.
- 4. Moustefa Taha Al-Khater seventeen years old.

The other children are:

5. Lewand Mustefah Adnan 2 years old got injury in his head in Mirkan village in $11\2\2018$.



Efrîn city:

The first victims in Efrîn city because of Turkish airstrikes in 20\1\2018 were two children from the same family one died and the other got serious injuries. This family was IDPs from Idlib who came to Efrîn.

The victim is:

1. Yihya Ahmed Hemedah 9 years old.



The wounded is:

2. Khaled Ahmed Hemedah 11 years old got injuries in his belly and his medical situation is very critical.

The result of the Turkish bombing in the villages on boarders led to families leaving their houses and moving to Efrîn city center among these families was Alieko family who moved from Jelemah village running away from Turkish fires there, they stayed in one of the building's basements in Turnidah village. Seven members from Alieko family were victims:

The victim is:

1. Arhat Ahmed Alieko 9 years old got martyred even though doctors tried really hard to save him.



The wounded are:

1. Mohemmed Ahmed Alieko (10 years old) got fragments in his leg and wrist.



2.Abdo Mousa (11 years old) got injury in his thigh.



3.Rouha Ahmed Mohemmed (10 years old) got her nose broken due to Turkish attacks against Al Mehmoudiya nieghbourhood in 13\2\2018.

Bilbileh district:

From the very first day Bilbileh district was under the severe attacks to the extent most villagers left their houses to save their lives.

The wounded are:

- 1. Abdo Shieko (2 years old) got injury in his forehead in 13\2\2018 in Khoutah village.
- 2. Mohemmed Noury Ibrahim 10 years old got bruising in his head in $15\2\2$ 018 in Khoutana village.
- 3. Kawa Ahmed Hebib 17 years old got fragments and breaking in his thigh in 18\2\2018. In Khoutah village.

Rajo district:

This district, especially its border villages, was the direct targets of the Turkish fires and the Jihadist groups. The severe attacks led people move from their villages and Rajo's children were victims.

The victims are:

1.Mohemmed Khalil Beker 10 years old got martyred in 22\1\2018 in Al Teniyaw village.

The wounded are:

- 1.Hiba Akram Osman 13 years old got injury in her forearm in 21\1\2018 in Adamo village.
- 2.Mustefah Apo Hemo 12 years old got injuries in his lower limbs in 21\1\2018.
- 3. Mohemmed Sido 5 years old got fragment in his foot in 26\1\2018.

4. Rojin Kharaman 16 years old got injury in her face.

Shiyeh district:

The caves in Shiyeh district is full of the civilians fleeing due to Turkish fires and attacks but it is obvious that Turkish aircrafts insist on targeting innocent children.

The victims are:

1.Mohemmed Khalil Beker 10 years old got martyred in 22\1\2018 in Al Toniyaw village.

The wounded are:

- 2. Roujhat Ahmed 3 years old got injury in his chest in 23\1\2018.
- 3. Hussien Hesen Hemgolin 16 years old got in his shoulder in 23\1\2018.
- 4.Ahmed Mohemmed Kheljeko 7 years old got injury in his head in 3\2\2018 in Chakhalaw village. In the same incident, his mother Zerifa Beyder Gezo got injuried.



5.Heva Mohemmed Ahmed 16 years old got injury in her wrist in 3\2\208 in Chakhalaw village, her parents got injuried in the same incident (Fatmah Jamil Mustafah and Mohemmed Ahmed).

The number of victimized children increases daily as the Turkish attacks continue on Efrîn. Therefore, we ask Human Rights Organizations to do their jobs stopping the Turkish attacks on civilians and punish Turkish government at committing war crimes against childhood. We also ask the UN to put into consideration children's situations in basements, caves and unsuitable places.

The victims mentioned above are those we could document them with names and photos. It is highly likely that the actual number of victims is higher than stated in this report.


DETAILED DOCUMENT ABOUT WOMEN IN EFRÎN, VICTIMS OF TURKISH ATTACKS

Turkey claims that its war against Efrîn is a war on terrorism, but in fact the civilians are the real victims of its illegal war. Women and children have been targeted many times by Turkish airstrikes and rockets. Women's loss specially mothers who are the basic stones in families, mean a serious loss in the society itself even the land itself. This report will consider victimized women from 20\1\2018 to 18\2\2018, it is also attached with photos of some women, unfortunately, and we couldn't get all photos due to difficulties at recognizing the bodies of the women victims.

Until 26-2-2018 the number of victimized women have reached to (65) among them (48) wounded and (17) dead.

In Bilbileh district numbers of victimized women due to Turkish attacks were (5) wounded:

1.Mema Resho 74 years, a mother got a fragment in her knees on 31\1\2018.



2. Ameena Khalil Horo 70 years , a mother got shot in her forehead on $5\2\2$ 018 When Turkish shells targeted Kutana village.

3.Zeynab Ahmed 70 years, a mother got shot in her feet on 13\2\2018. Her husband Khalil Ahmed got injuries in his head and feet due to Turkish attacks on Sherqiya village.



4.Ameena Noury Rasheed 42 years, a mother got injuries in her shoulders and head on 15\2\2018.

5.Na'yema Mohemmed Shukry 58 years, a mother got bruising in all her body on 15\2\2018.

In Jendyras district numbers of victimized women in Turkish attacks have reached (15) women among them (12) wounded and (3) martyrs:

The wounded are:

- 1.Baseema Mohemmed Ba'jo 32 years a mother got minor injury on 23\1\2018.
- 2.Zeynab Yousef 55 years, a mother got injuries in her head on 23\1\2018.
- 3. Silva E'ad 30 years got psychological shock on 21\1\2018.
- 4. Nazeera Haj Mahmoud 50 years, a mother got her left thigh broken on 23\1\2018.
- 5. Seepan Ali 24 years, a young woman got psychological shock on 24\1\2018.
- 6. Sherevan Amin 32 years got shot in her left foot on 24\1\2018.
- 7.Wadeh Ahmed Shawak 65 years a mother got bad injuries in her cheek on 26\1\2018.
- 8.Feeda' Ali 22 years, a young woman got bruising n all her body on 27\1\2018
- 9.Merkan E'ad 21 years, a young woman got shot on 25\1\2018.
- 10. Arin Hesen 33 years, got injuries in her head on 23\1\2018.
- 11.Ameena Khalil 50 years, a mother got a fragment in her leg and injuries in her nose in 23\1\2018. It is worth to mention that her fourteen-year old son got martyred in the same incident.



12.Debah Ahmed 35 years old, got a sniper's shot in her thigh on 9\2\2018. In Dier Belut but her misery did not stop there because her twins Mehmoud Beder Dirmosh got injuries in his head and Mustafa Beder Dirmosh (10 years old) got shot in his ureter.



The women martyrs are:

- 1.Almazeh Shieko Horo 50 years got martyred on 23\1\2018.
- 2. Houriya Abd Alhameed Al hejras 45 years got martyred on 13\2\2018.
- 3.Unknown woman 55 years got martyred on 23\1\2018.
- 4.Sewsan Jamil 35 years got martyred on 22\1\2018 in Tel Silor village leaving her son Mohemmed Jamil Sulieman orphan with injuries in his leg, too.

In Rajo district numbers of victimized women have reached (7).

The wounded are:

- 1. Rouhev 22 years got bruising in her body on 21\1\2018.
- 2.Deryan Mohemmed Seedo 20 years got injuries in her jest and ankle on 21\1\2018.
- 3. Rouyedah Ibesh 23 years got psychological shock on 29\1\2018.
- 4.Zahra Ahmed Al Dourzy 26 years, a journalist for France Press channel got bruising in her body on 30\1\2018.
- 5.Medineh Abdo Husien 55 years, a mother got her lower limps cut on 30\1\2018. Form Huseh village. She was trying to save her injuried husband Mohemmed Rasheed Ali as they were on their way to the hospital, when another shell hit their car leading to husband's left leg loss and Naseeb Rasheed the husband's brother had his wrist cut.



The martyrs are:

- 1. Avin Azad in the twentieth got martyred on 21\1\2018.
- 2.Shemsa Mousa 75 years got martyred on 23\1\2018. She got martyred within ten days after she suffered a lot. Her story did not end here, her eight-year old son Shiyar Kwans and her daughter Henifa Kwans sixteen years old had lost her memory.

In Shera district numbers of victimized women have reached to three wounded women:

- 1.Unknown woman got injuries in her face on $21\1\2018$.
- 2.Fikret Ali Hesen 51 years, a mother got a fragment in her right leg on 17\2\2018.from Gubelak Village. It was not enough for her to change her place twice once from Aljeya village to Rajo and then from Rajo to Gubelek. Because of Turkish attacks she was injured and her children became homeless.



3.Jeylan Mohemmed 30 years, a mother who was kidnapped with her husband Mohemmed Kedro by Turkish gangs and jihadists. After two days of beating and torturing they let them go. They were taken to the hospital. She got injuries in her leg and her husband was shot in his belly.

In Sherwa district numbers of victimized women have reached to (6) due to Turkish attacks.

There is one wounded woman called Bedriya Abd Allah Keno 18 years got a fragment in her right leg and not to forget that Keno's family had a massacre by the Turkish airstrikes. Keno family of 25 people were IDPs in Gubeleh village.

The martyrs are:

- 1. Jouriyah Keno 45 years, a mother got martyred on 28\1\2018.
- 2. Rewan Al Asswad 20 years got martyred on 28\1\2018.
- 3. Fatemah Abd Rebo 40 years a, a mother got martyred on 21\1\2018.



- 4.Unknown woman 30 years got martyred in 21\1\2018.
- 5. Rehef Al Hussien 33 years, a mother got martyred in 21\1\2018.

It is worthy to mention that Jouriyah , Rewan and Fatemah Abd Rebo are from the same family (keno family) who were massacred by the Turkish airstrikes.

As for Rehef and unknown women they are from one family who were IDPs from Idlib came to Efrîn to look for better life. In this massacre 24 people were victims 11 martyrs, 7 wounded and 5 missing.





In Shiyeh numbers of victimized women have reached to 16 due to Turkish attacks.

The wounded are:

- 1. Asya Shieck Murad 70 years, a mother got injuries in her head on 23\1\2018.
- 2. Fayrouz in her twentieth got injuries in her back on 21\1\2018.
- 3. Henan Alan 20 years got shot in her thigh on 21\1\2018.
- 4.Kajeen Shieck Mohammed in her twentieth got bruising in her left foot on 21\1\2018.
- 5.Faridah Shieck Mohemmed in her twentieth got bruising in her left foot on 21\1\2018.
- 6.Zieynab Hemgoleno 40 years, a mother got injuries in her head on 21\1\2018.
- 7.Zarifa Beyram Gezo 34 years, a mother got bruising in her foot on 3\2\1018. Her son Ahmed Mohemmed Keljeko 7 years old got injured in his head.

- 1.Amara Ali 21 years got martyred on 21\1\2018 after sever wounds.

This family came from Til Kirah to Mobeta for a better life and they did not know that they will be victims of Turkish attacks.

1.Ameena Mustafa Al Khetre 40 years, a mother got martyred on 26\1\2018.

As for Efrîn city and surrounding towns numbers of victimized women have reached to (6) women due to Turkish attacks.

The wounded are:

- 1. Viyan Rasheed in her twentieth got psychological shock on 21\1\2018.
- 2.Salwa Mohemmed Meho 35 years got psychological shock on 23\1\2018.
- 3.Gulah Mohemmed Khalil 40 years, a mother got bruising in all her body on 31\1\2018. Her family who already ran away from Turkish fires in Jelmah town to take a shelter in one of the building's basement in Turendah village.
- 4. Halema Ahmed Menkawy 70 years, a mother got injuries in her head in 31\1\2018.
- 5. Ameena Abd Allah Feraj 50 years, a mother got injuries in her thigh.
- 6.Nezhet Mhemmed Mohemmed 50 years got bruising in all her body on 31\1\2018.

The Died person is:

1.Ameena Shaheen 50 years, a mother whose heart stopped because of the great shock she got during Turkish airstrikes against Efrîn on 9\2\2018.

At the end of this report we assure that attacking women and children is a war crime that the international laws punish and forbid. Some women are in critical medical situations especially who lost their limbs, sides or have psychological shocks. As for the mothers who died and their children have become orphans, it is enough to ask who is going to compensate them from the suffering caused by Turkish government to their families after they lost their lives and have become war victims unjustly.

REPORT ABOUT BASUTEH MASSACRE

In 19\2\2018 Turkish shells targeted Basuteh village in Sherwa district. The sever attacks led to a massacre in a family of nine members, a child died and eight were wounded. There was also another civilian wounded in a car accident as he was trying to run away from Turkish bombing.

The victim is:

1. Heva Ahmed Kilaho 13 years old.



2. Mohemmed Ziad Kilaho 8 years old got fragments in his hand and thigh.



3. Jenav Ziad Kilaho 11 years old got injuries in her knee.



4. Shivan Khalil Kilaho 6 years old got many fragments in all his body.



5.Henan Mohemmed Kilaho 11 years old got injuries in his back and foot.

The other civilian is:

Basel Jumah Omar 24 years old got bruising in his body. He was trying to escape the Turkish attacks on the village when he had a car accident.

From the objective evidences showed above and documented by multiple testimonies, videos and photographs, as well as by international humanitarian organizations and international press, it emerges that the Turkish state and its allies operating in that area are carrying out criminal actions against population living in and around Efrîn and this situation have led to the violation of human rights and in particular the right to life, the right to security, the right to cultural, social and personal identity, the right to political and religious convictions; these actions may be qualified as crimes against humanity.

Today, I received information that the area of Afrin inhabited by Kurds, Yazidis and Christians is under siege from all sides. There is only one road through which people can leave the city. 200 civilians have been killed, including 3 Yazidi children. Shrines and religious sites have been destroyed or forcibly converted into mosques. Peoples homes are being looted and minorities are being shamed by extremist militias.

Many of these actions are war crimes and should be documented. This horror is reminiscent of the initial actions of ISIS in Iraq. Medical and healthcare services are urgently needed. This situation foreshadows "ethnic cleansing" and genocide.

I appeal to the UN, the EU, and UN Security Council to demand that all sides respect the rights of civilians and work toward a cease fire. I also call on humanitarian organizations and UN agencies to provide support to civilians in the areas where access to food and medical is rapidly disappearing.

All sides in Syria should work together for a peace process that will ensure peace, stability, the protection of the rights of all religious and ethnic minorities. Now is the time to heal wounds, avoid further escalations and return to normality for people in Iraq and Syria.

"Eziden in Afrin rufen um Hilfe"

Seit über 40 Tagen bombardiert die türkische Armee die Region Afrin, auch die dortigen Ortschaften der Eziden. Die türkische Armee kämpft Seite an Seite mit jihadistischen Gruppen gegen die Kurden und andere Minderheiten, wie die Eziden, Aleviten oder Christen. Dieser Krieg entwickelt sich zunehmend zu einem Religionskrieg. Seit Beginn des Krieges sind bis jetzt mehrere Hundert Menschen ums Leben gekommen, überwiegend Zivilisten. Seit gestern steht die türkische Armee zusammen mit den Jihadisten vor der Stadt Afrin mit ihren über 400.000 Einwohnern.

Der Zentralrat der Eziden in Deutschland weist seit Wochen auf bevorstehende Gefahr hin und fordert die internationale Gemeinschaft auf, schnell einzugreifen, um einen Blutbad an den Eziden zu verhindern.

Der Krisenstab des Zentralrates der Eziden in Deutschland nimmt seit gestern nur noch verzweifelte Hilferufe wahr. Ein Gespräch kommt nicht zustande. Dazu der Leiter des Krisenstabes, Sheikh Esmat Barimou: "Seit gestern versuchen wir mit den Eziden in Afrin in Kontakt zu treten. Einige unsere Kontakte sind nicht erreichbar, andere schreien nur noch um Hilfe. Sie haben weder Wasser noch Nahrung. Sie hätten sich in den Kellern der Häuser, die überfüllt sind, versteckt. Die türkische Armee bombardiere die Stadt und die Jihadisten bereiten sich auf einen Angriff auf die Stadt vor. Die Familien seien auseinandergerissen, und man wisse voneinander nichts. Die Eziden sind in der Falle, wenn man ihnen nicht von außen helfe. Ich bitte und appelliere an die Weltgemeinschaft, allen voran die USA und Russland und an die Menschheit, diesen Krieg sofort zu unterbinden."

Sheikh Fakhraddin Abdo, Mitglied des Krisenstabes appelliert an die Eziden in Deutschland, sich ab jetzt überall an friedlichen Demonstrationen, Kundgebungen und Protesten zu beteiligen bzw. eigene zu organisieren. Dazu sagt er: "Wir hatten noch die Hoffnung, dass die Weltgemeinschaft interveniert, um diesen Krieg zu beenden, insbesondere als die syrische Armee angekündigt hatte, in Afrin einzumarschieren. Unsere Hoffnung scheint jedoch vergeblich zu sein. Afrin ist eingekesselt und unsere Verwandten befinden sich in der Falle. Ähnlich wie in Shingal rechnen wir mit einem Massaker durch die Jihadisten, denn diese Jihadisten lassen sich auch nicht von der türkischen Armee kontrollieren, sie töten und rauben wahllos. Ich bitte alle Eziden weltweit, sei es aus dem Irak, aus Russland, aus der Türkei oder aus Syrien für die Eziden in Afrin auf die Strasse zu gehen. Lasst unser Volk in Afrin nicht allein!"

"الايزيدييون في عفرين يطلقون نداء المساعدة!"

منذ أربعين يوماً تقوم القوات التركية بقصف مدينة عفرين ، و من ضمنها القرى الايزيدية في المنطقة القوات التركية تحالفت مع الجهاديين لمحاربة الكورد و الأقليات الدينية مثل الايزيديين و العلويين و المسيحيين متخذة طابعاً دينياً واضحاً من صرخات الجهاديين و شعاراتهم و طريقة تعاملهم مع الأسرى . منذ انطلاق هذه الحملة العسكرية سقط المنات من الضحايا ، جلهم من المدنيين العزل. منذ يوم امس تقف القوات التركية مع الجهاديين على أطراف مدينة عفرين لاقتحامها ، جدير بالذكر يسكن المدنينة حوالي ٤٠٠ الف نسمة و نتوقع حدوث كارثة إنسانية حقيقة في حال حدوث ذلك .

منذ أسابيع يطلب المجلس الاستشاري الايزيدي في المانيا من الجهات الدولية بوقف هذا العدوان و يحذر من حدوث مجازر بحق الايزيديين في المنطقة .

فريق أزمة عفرين التابع للمجلس يحاول منذ أمس دون جدوى الاتصال مع الجهات الدولية ذات النفوذ في المنطقة . حيث يقول مسوول فريق أزمة عفرين الشيخ عصمت بريمو (هو شخصياً من أهالي عفرين) : منذ يوم أمس نحاول الاتصال بأهلنا في عفرين ، البعض من الذين كانوا على اتصال معنا و يزودونا بالمعلومات لم يعد لهم اثر ، البعض الاخر يستنجد بنا و يطلب المساعدة ، حيث يخبؤون أنفسهم في اقبية المنازل فلا ماء و لا اكل لديهم الديم التركية تقوم بقصف المدينة و الجهاديين يستعدون لاقتحامها . الكثير من العوائل تفرقوا و فقدوا الاتصال فيما بينهم . نطلب من الولايات المتحدة و روسيا بوقف هذه الحرب فوراً و بخلافه ينتظر الايزيديين المحاصرين مصيراً

عضو فريق أزمة عفرين الشيخ فخرالدين عبدو يحث الايزيديين في الخارج بالمشاركة في المظاهرات الجماهيرية و تنظيم الاحتجاجات بأنفسهم في مناطق تواجدهم، ويضيف:
كان لدينا الأمل بان الحرب ستتوقف و المجتمع الدولي سوف يتدخل ، خاصة بعد اعلان الجيش السوري الدخول الى عفرين ، لكن يبدو بأنها كانت مجرد امال . عفرين الان محاصرة و اهلنا ايضا محاصرين فيها ، حيث ينتظرهم مصير أهل شنكال في الثالث من اب ٢٠١٤ . هؤلاء الجهاديين لا تستطيع القوات التركية أيضاً السيطرة عليهم ، حيث نرى في وسائل التواصل الاجتماعي ما يقومون به من افعال مخزية من سرقة وقتل و إطلاق شعارات تكفيرية. اترجى جميع الايزيديين ،سواء ايزيديي العراق او سوريا او روسيا بالنزول الى الشارع و التظاهر من اجل عفرين ...
